#### NARRATIVE

On 04-24-11 at approximately 2017 hours I responded to 235 SW 4th St., in the city of Deerfield Beach in reference to a report of a suspicious incident/possible burglary in progress. Upon arrival I was "flagged down" by CURRY, NIKEYA who advised that she had called the police. CURRY, NIKEYA stated that the interior and exterior lights to the residence had been turned on and off. I asked CURRY, NIKEYA which was the house in question, she then directed me to 230 SW 4th St., by pointing at it. I then updated dispatch of the correct location and went to the front yard of the residence and gave dispatch the tag information from the two vehicles sitting in the drive way. (It was later learned that 235 SW 4th St. does not exist) CURRY, NIKEYA observed all this and stated to me that she was at that time on the phone with the home owner (BROWN, GEORGE), who was advising her the he and his family were not at the residence and that no one should be at the residence.

Deputy Phillips arrived on scene and we both took up positions of cover at 236 SW 4th St., and surveiled the residence as we waited for other units to arrive. Shortly after, CURRY, NIKEYA approached me and gave me a set of keys she said opened 230 SW 4th St., and was there with my self and Deputy Phillips and watched us as we surveiled the house. Upon further surveillance I observed a black male who later became known to me as SCARLETT, NEVILLE in through the kitchen window. SCARLETT, NEUILLE appeared to be doing dishes. SCARLETT, NEUILLE, was the only person we observed in the residence. As a further precaution I approached CURRY, NIKEYA again to ask if BROWN, GEORGE, rented a room to any one, or if the house was a "rooming house". I referenced the house at 230 SW 4th St., as the house in question by pointing at it. CURRY, NIKEYA again, confirmed that the house was supposed to be empty and no one should be in it. During this process several other units arrived on scene and surrounded the house. CURRY, NIKEYA was in and out of her residence as this was going on and never alerted deputies that the house that police was surrounding was the wrong house. Deputies were on scene for 17 minutes with out CURRY, NIKEYA alerting Deputies that the residence we had surrounded was the wrong house. During the time that we were surveiling 230 SW 4th St., at no time did I see lights go on or off at 236 SW 4th St.

Just prior to my self and Dep. Phillips knocking on the door we did observed the exterior and interior light come on and off. Also, a window was suddenly closed as well as the blinds. These actions confirmed that we were at the right house, as the lights were now being turned on and off as CURRY, NIKEYA had said. Also, the closing of the window and the blinds also heightened our suspicion as it now appeared that the possible suspects inside the residence were now aware that the police had arrived and were trying to conceal their activity.

My self and Deputy Phillips approached the side door (West Side) to the residence, weapons drawn, knocked on the door and announced ourselves by stating "Sheriffs Office" and told them to come to the door, when persons inside inquired as to whom was knocking at the door

I then observed SCARLETT, CARMITA thru the kitchen window, upon seeing her I told her to come to the door and come out side. During this time I had my weapon pointed at SCARLETT, CARMITA as I did not know the nature of the persons inside of the residence. Persons inside the residence were told to come out of the house with their hands up. SCARLETT, CARMITA exited the residence, followed by HOLMES, ILONA and SCARLETT, NEVILLE. HOLMES, ILONA exited the home and kept repeating "I'm Judge Holmes, I'm Judge Holmes, I'm Judge Holmes...." She also stated "I'm armed" a few times. HOLMES, ILONA exited the residence with a revolver in her hand. She was told several times to put the gun down, which she finally did. SCARLETT, NEUILLE; SCARLETT, CARMITA and HOLMES, ILONA were all told to sit on the ground. HOLMES, ILONA stated she could not because she had a bad back. None of the residence complied with police. CARLE, KIANA, was also told to come out of the house before it was cleared by myself

and Dep. Phillips. They appeared very upset that police had pointed weapons at them. When speaking with the residence later on, they advised that they had seen the police out side the residence, and knew that the residence at 236 SW 4th St., (Also known as "The Pastors House") was possibly being burglarized, due to the fact that CURRY, NIKEYA had called them and told them to "Be Careful".

It was then that Deputies learned that the house in question was actually 236 SW 4th St., the home right next to 230 SW 4th St.

Upon a check of 236 SW 4th St., it was discovered that the front door was unlocked. Upon myself and Deputy Morrisroe entering the house the alarm was activated. The house was then cleared. BROWN, GEORGE the owner of 236 SW 4th St., arrived home and upon a check of the interior advised that nothing seemed out of place or was missing. Upon inspection for the structure no forced entry could be located. Further investigation revealed the following; RAY, MATTHEW, and his brother LEUINE, ARTEZ were sitting on their front porch when they saw lights going on and off inside the residence of 236 SW 4th St. RAY, MATTHEW then called BROWN, GEORGE. BROWN, GEORGE then advised RAY, MATTHEW to tell his mother to call the police. His mother being in the shower, RAY, MATTHEW notified CURRY, NIKEYA. During this time LEVINE, ARTEZ took a set of keys that his mother has for the residence, and unlocked the front door of 236 SW 4th St and then went back to his house.

I also learned that one of the occupants of 230 SW 4th St., accused me of breaking the window to the left of the west side door when I was knocking. Upon inspection of the window I observed a hole in the glass. However the hole had already been taped over with clear tape. The adhesive side of the tape that was covering the hole was covered with dirt, indicating that it had been there for some time. There was also no broken, loose glass in the window sill, indicating that the broken, loose glass had been removed when the window was repaired.

When asked later on why HOLMES, ILONA came out of the house with a gun in her hand she stated that she did not know if deputies were who we said we were or burglars. She also stated that she felt that had she not been there police would have mistreated her family. She also stated "There was no way I was going to sit on the ground, You'd have to shoot me to get me to sit on the ground tonight." When I asked HOLMES, ILONA for her information for this report she stated to me from inside the residence that she was in the processes of "Soaking her feet" and "Now was not a good time." Sgt Pugliese responded to the scene as well, and spoke with all involved. Photographs of the broken window were taken and filed along with this report. Nothing further.
